Policy Code: 4600 Student Fees

The Cumberland County Board of Education recognizes the need for certain student fees and charges to fund certain school activities that are not adequately financed by local, state or federal funds. It also recognizes that some student may not be able to pay certain fees or charges. Therefore, it is the policy of the board that no student shall be denied an education because of his or her inability to pay any fees or charges. The board will strive to hold student fees to a minimum.

Pursuant to state law, the board will periodically review and approve all student fees/charges. No student shall be required to pay any fee or charge which has not been approved by the board for materials, supplies or equipment in any course or instructional program offered by the school system.

However, students enrolled in career and technical education or other special courses may be charged for the cost of raw materials used by them in producing or creating projects while learning the skills taught by the course, provided the end product becomes the student's personal property.

The superintendent shall annually submit the schedule of approved fees and charges to the superintendent of public instruction.

A. REQUIRED FEES

Fees shall be assessed for lost or damaged books, materials, supplies and equipment and for damage to school buildings and property in accordance with policies 6525, Textbook Accountability, 6550, Vandalism and 9200, Care and Maintenance of Facilities and any applicable regulations established by the superintendent. Waivers for economic hardship as described in Section D shall not apply to such fees.

B. SYSTEM-WIDE FEES AND CHARGES FOR PARTICIPATION IN OPTIONAL SERVICES AND ACTIVITIES

Reasonable system-wide fees and charges shall be established and approved by the board for certain optional services and activities. These fees and charges may include but are not limited to: (1) child nutrition program charges, (2) musical instrument rental fees, (3) publication fees (e.g., yearbook, newspaper), (4) student picture fees, (5) automobile registration fees, (6) lock fees, (7) charges for student insurance, (8) admission to athletic events, (9) graduation fees (e.g., caps and gowns), (10) transcript fees, (11) drivers' education class fees, and (12) materials fees. Additional system-wide fees for optional services and activities may be approved by the board upon recommendation of the superintendent.

Fees for Advanced Placement examinations will be charged in accordance with policy 3452, Advance Placement Course Program.

C. LOCAL SCHOOL FEES

The board delegates to each school principal the authority and discretion to establish, subject to approval by the superintendent and board, additional optional fees or charges at the local school level. These may include, for example, fees or charges for class or club dues, concession sales, school store merchandise, prom, and student identification cards. Each principal is required to submit a list of any such fees to the superintendent for approval by the board no later than the August board meeting. The superintendent shall adopt procedures to ensure that such fees are reasonable and consistent among the different levels and schools.

D. WAIVER OF FEES FOR ECONOMIC HARDSHIP

Any system-wide or local school fees or charges established under this policy will be waived or reduced for students who demonstrate economic hardship. On appropriate forms, made available upon request, those financially unable to pay may apply in confidence to the school principal for waiver or reduction of school fees. The school principal will approve or disapprove each request. The principal's decision may be appealed (see policy 1740/4010, Student and Parent Grievance Procedure).

The written application for a waiver must be accompanied by supporting documentation which shall include either:

- 1. An indigent memorandum from the Department of Social Services; or
- 2. Evidence that the family has unusually high medical bills, shelter costs in excess of 30 percent of income, special education expense due to disability of a child, or disaster or crisis expenses.

If school officials determine at any time during the school year that the student no longer meets the criteria for economic hardship, the principal or designee shall notify the student and parent in writing that fess are due and payable.

E. NOTICE OF FEES AND CHARGES

Each principal annually shall publish in the school's student handbook, post on the school website, or otherwise provide in written form the schedule of all applicable fees and charges. The notice shall advise that fees and charges are to be paid within 30 days of the date of enrollment or other deadline and the possible penalties for failure to pay. If a fee or charge remains unpaid when due, the principal shall notify the parent or guardian of the student in writing of the debt and penalty for nonpayment. The notice shall further advise students and parents that required fees and charges may be waived for demonstrated economic hardship and shall explain the process for requesting a fee waiver or reduction.

F. PENALTIES

If a fee or charge has not been paid or arrangements have not been made for the payment of a fee or charge, the principal 4600

may impose consequences, including but not limited to the following: (1) excluding the student from participation in extracurricular activities, other fee-supported activities or projects that involve the collection of money or goods; (2) withholding the student's class schedules until the first day of school; or (3) instituting legal proceedings in small claims court.

G. COLLECTION AND CARRYOVER OF FEES AND CHARGES

The school principal shall be responsible for collecting all fees and charges approved by the board and any fines or other debts owed by students to the school system. Any fee or charge due to be paid to any school in the system and not paid at the end of the school year shall be carried forward until the next succeeding school year, as such debts are considered to be debts of the student to the school system and not to a particular school.
