3.01 Superintendent's Update - Dr. Marvin Connelly

Dr. Connelly began by reflecting on the past year and the lessons learned while navigating through COVID-19. He shared his appreciation to students, parents, employees, community partners and the Board for pulling together during this time

Dr. Connelly provided an update on our Summer Learning Program (RISE). He appreciates everyone involved in helping our students thrive.
