# 3. Superintendent's Update / District Highlights - Dr. Marvin Connelly 3.01 Superintendent's Update - Dr. Marvin Connelly

Dr. Connelly began by sharing his appreciation for the incredible work being done by our students and staff every day in our district.

February is Black History Month and provides an opportunity to celebrate the achievements of African Americans. We are thankful every day for the contributions and support of the African-American Community here in Cumberland County. In addition to the celebrations taking place at schools throughout the district, our Academic Services team has lined up a Black History Month Speaker Series, which will include numerous African-American authors and illustrators. They will be featured at school and community events throughout the month.

As we prepare to celebrate Public Schools Week at the end of February (Feb. 21-25, 2022), we are highlighting what makes Cumberland County Schools unique. One of the unique educational opportunities offered through CCS is our Career and Technical Education Program. During the month of February, we are celebrating Career and Technical Education Month. Through CTE, our students gain access to specialized career pathways and leave our classrooms ready for life. This week, CCS celebrating National School Counseling Week. School counselors galvanize resources and supports to ensure the educational, personal and social development of every child. During the week of Feb.14-18, 2022, we are celebrating Love the Bus/Bus Driver Appreciation Week.
