The Cumberland County Board of Education met in-person and virtual on Tuesday, April 13, 2021 at 6:30 PM with the following board members present: Alicia Chisolm, Greg West, Deanna Jones, Susan Williams, Nathan Warfel, Charles McKellar and Donna Vann. 3.01 Superintendent's Update - Dr. Marvin Connelly

Dr. Connelly began by sharing observances during the month of April: Month of the Military Child

Next, Dr. Connelly provided an update on Plan A. We successfully transitioned to "Plan A" this week. Around 61 percent of CCS students are enrolled in the in-person learning option, while 39 percent of them have remained remote learners. Our premier professionals have worked diligently to accommodate the learning options selected by families and continue to provide high-quality learning experiences for our students. Similar to school districts across the state and nation, our schools are navigating through some staffing challenges related to quarantines and resignations. However, our premier professionals have been resilient and have deployed a variety of strategies that were built into their reopening plans to address these challenges. As we prepare to close out this current school year and begin planning for the fall, we are in close contact with local and state officials to stay abreast of health and safety protocols that may impact our back-to-school plans in the fall.

This week, our leadership team attended a webinar with staff from DPI to learn more about ESSER funds, including the required back-to-school plan that each district must submit as part of the planning process for ESSER III funds.

At this time, one change we foresee is the elimination of Wellness Wednesdays when we return this fall, allowing students to attend school for in-person learning five days each week.

Another anticipated change is the virtual learning option for students. In the fall, we do not plan to offer a full-time virtual learning option at every school. We will allow families who want their children to remain virtual to enroll in one of our Cumberland Academies. I will continue to keep the Board updated as we work through the planning process. Of course, the safety of our students and staff remains our top priority, while we also work to transition back to our normal school operations.

In closing, Dr. Connelly shared his deep appreciation for the continued leadership of our Board as we navigate through this school year.
