Board Members Did Not Approve a Policy Revision Proposed for Participating in 'Extracurriculars'

The Board voted 3-6 to maintain the current *Policy Code 3620 Extracurricular Activities, Cocurricular Activities and Student Organizations* regarding student participation. The policy states that the requirement of "a 2.0-grade point average or a minimum average of 70 for the previous semester is required for students to participate in activities..."

2017 Kindness Awareness Proclamation Embraced

The Board approved adopting October as Kindness Awareness Month in the Cumberland County Schools. The proclamation states that it is "a good time to remind all of us of the need to remember that Respect, Dignity, Compassion, and Humility are four essential ingredients in the creation and maintenance of a safe and productive school environment." The document encourages the CCS "to cultivate caring, kindness, and compassion within our schools and community through our youth by teaching them to make a difference by completing random acts of kindness." In line with the proclamation, CCS' Anti-Bullying Task Force and the DoDEA Grant Project are challenging the students and staff at every school and Central Services building to complete at least 5,000 acts of kindness throughout October. 'The kindest elementary, middle, and high school in Cumberland County' will be recognized at the November Board of Education meeting. Kindness organizers hope this effort coupled with numerous others at each school will decrease the number of bullying claims and discipline referrals as well as make a difference in overall student interaction this school year. #GoBeKindCCS

6th-Grade Athletic Participation Gets Approved

After much discussion, members of the Board voted 6-3 to approve sixth-grade students participating in sports. Through a survey, it was found that six local middle schools supported the move, while eight were against it citing safety, emotional, mental, and physical maturity as drawbacks. According to information from CCS' Director of Student Activities Vernon Aldridge, 73 out of 101 school districts in North Carolina currently allow sixth graders to participate in school sports.

Superintendent Search Information Shared with Board

A representative from the North Carolina School Boards Association, who has been contracted to assist the school system with selecting a new superintendent, shared initial draft documents with the Board that outlined the search timeline, vacancy advertisement, a sample application, and a sample community and staff survey. The timeline <u>draft</u> sets March 21, 2018, as the date for the announcement and introduction of the new superintendent.
